

“SUN. FUN. DONE.” PROMOTION

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

INTERNET ACCESS AND VALID EMAIL ADDRESS REQUIRED.

- 1. PROMOTION DESCRIPTION:** The “Sun. Fun. Done.” Promotion consists of a sweepstakes (“**Sweepstakes**”) and an instant win game (“**Game**”) (collectively, the “**Promotion**”); begins on 5/6/18 at 12:00:00 AM Eastern Time (“**ET**”) and ends on 6/30/18 at 11:59:59 PM (ET) (the “**Promotion Period**”). There is one (1) Grand Prize available in the Sweepstakes (also referred to as “**Sweepstakes Prize**”) and there are five thousand five hundred (5,500) available Instant Win Game Prizes (also referred to as “**Game Prizes**”) in the Game. Participation in the Promotion does not constitute participation in any other promotion, contest or sweepstakes. By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Edgewell Personal Care Brands, LLC (“**Sponsor**”) and Administrator, which shall be final and binding in all respects. The administration of the Promotion will be conducted by TPG Rewards Inc., 29 Broadway, 14th Floor, New York, NY 10006 (“**Administrator**”).
- 2. ELIGIBILITY:** Open only to individual, legal residents residing in the fifty (50) United States, the District of Columbia (“**D.C.**”) and Puerto Rico, who are 18 years of age or older as of the date of entry (19 or older in AL and NE). Text STOP to cancel. Not all mobile devices feature text message capability; and, text messaging functionality may not be available in all areas. Only purchase of a Participating Product at a participating Walgreens or Duane Reade by Walgreens store or at www.walgreens.com is valid for this Promotion. BONUS SWEEPSTAKES ENTRY: Each eligible entrant will be presented with an opportunity to earn an additional entry into the Sweepstakes by answering a Sun Care Tip question, which will be presented to the entrant on the site after completing a Game play. Sun Care Tip question need not be answered correctly in order for him/her to receive additional entry.

An eligible entrant may enter the Sweepstakes a maximum of one hundred twelve (112) times; one (1) entry plus one (1) bonus entry for each game play per day.

5. GRAND PRIZE WINNER DETERMINATION AND NOTIFICATION: Potential Grand Prize winner will be selected in a random drawing on or about 7/9/18 from among all eligible entries received from all methods combined by Administrator. The decisions of the Administrator (as well as of Sponsor) are final and binding. Potential Grand Prize winner will be notified by email, phone and/or mail, using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by the potential winner for any reason. If, despite reasonable efforts, the potential winner does not respond within five (5) days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit the Grand Prize and an alternate winner may be selected. 6. PRIZES:

UNCLAIMED/UNREDEEMED GAME PRIZES WILL NOT BE AWARDED.

SWEEPSTAKES PRIZE: One (1) Grand Prize: (“Grand Prize”) a four (4) day, three (3) night trip for winner and up to three (3) guests (“Guests”) to Universal Orlando Resort in Orlando, FL (“Trip”).

Grand Prize will include:

round trip economy class air transportation for winner and up to three (3) Guests from a major commercial airport near winner’s home (as determined by Universal Orlando in its sole discretion) to Orlando, FL *; three (3) nights standard hotel accommodations (one room, quadruple occupancy, room and tax only) at Loews Sapphire Falls Resort or at another on-site hotel (as determined by Universal Orlando in its sole discretion); non-exclusive ground transportation to and from destination airport and hotel*. 3-Park 3-Day Park-to-Park theme park tickets for admission to Universal Studios Florida and Universal’s Islands of Adventure theme parks and Universal’s Volcano Bay water theme park for winner and up to three (3) Guests; and admission to one (1) performance at Blue Man Group Show (exact date and time to be determined by Universal Orlando in its sole discretion) for winner and up to three (3) Guests (collectively the “Trip”);

and \$1,000 in spending cash (for winner only – to be awarded in the form of a check from Sponsor to the winner).

The Approximate Retail Value ("ARV") of the Grand Prize is Four Thousand Seven Hundred Forty-Five Dollars and 93/100 Cents (\$4,745.93).

Trip must be completed by 7/31/19 or Prize may be forfeited. Travel dates and arrangements are subject to air travel, holiday, blackout dates, and other prize and travel restrictions. Travel dates are subject to Universal Orlando and Sponsor approval. Reservations are subject to availability. Trip must be booked at least sixty (60) days prior to intended departure date. INSTANT WIN GAME PRIZES

One Hundred (100) \$15 Summer Fun Cash Cards will be available throughout the Promotion Period. Summer Fun Cash Card is a non-reloadable debit card.

Four Hundred (400) \$10 Gas Cash[®] Cards will be available throughout the Promotion Period. Gas Cash[®] Card is redeemable at participating U.S. gasoline stations for the purchase of gasoline.

Five Thousand (5,000) \$5 Walgreen Gift Cards will be available throughout the Promotion Period.

Instant win Game prizes must be claimed by entrant during same session as corresponding Game play.
